The Extraordinary General Meeting of Shareholders No.1/2016 held on 2 September 2016 passed a resolution to approve the issuance newly issued ordinary shares in combination with Warrants to purchase ordinary shares of NEP Reality and Industry Public Company Limited No. 3 (NEP-W3) to be offered for sale to existing shareholders in proportion to their shareholding (Right Offering) at the ratio of 3 existing ordinary shares to 2 newly issued ordinary shares in combination with 1 units of Warrants (3:2:1). The offering price of newly issued ordinary share is Baht 0.45 per share. The offering price for Warrants is Baht 0.00 per unit (free of charge). Since the newly issued shares are offered at the price of Baht 0.55 per share which is less than 90 percent of the weighted average market price of the Company's ordinary shares during the last 7 consecutive business days prior to the first day on which an investor will not be granted the right to subscribe to newly issued ordinary shares (the first date on which the SET posts an XR sign is 8 September 2016), resulting in the adjustment of the Exercise Price and Exercise Ratio of Warrants to purchase ordinary shares of NEP Reality and Industry Public Company Limited No. 2 (NEP-W2).

Therefore, NEP Reality and Industry Public Company Limited shall adjust the Exercise Price and Exercise Ratio of Warrants to purchase ordinary shares of NEP Reality and Industry Public Company Limited No. 2 (NEP-W2) according to the formula provided in Clause 1.4.1. of Rights and Duties of the Warrant Issuer and Holders of the Warrants to Purchase Ordinary Shares of NEP Reality and Industry Public Company Limited No. 2 to ensure that the benefits of the holder of Warrants are not less than the existing status
